## **Directions to Proposed Artist Village in Marina, CA**

### **Driving North on Hwy 1 from Monterey:**

Take Imjin Pkwy exit;  
Right on Imjin Pkwy;  
Right on 2nd;  
Right on Divarty Street (Marina/Seaside boundary & last row of barracks);  
Right on unmarked street (sign that reads "Fort Ord State Park"), which is 1<sup>st</sup> Street;  
Proceed on 1<sup>st</sup> Street almost to VA DoD Clinic (before VA DoD Clinic  
notice long building on left side of street. Park on street adjacent  
to end of the north-side of building (1<sup>st</sup> & 8<sup>th</sup>). We will enter from the north end of the  
building.

Arrow #1: MUST TURN RIGHT At 2<sup>nd</sup>

Arrow#2: MUST TURN RIGHT At Divarty Street

Arrow#3: MUST TURN RIGHT On unmarked street (1<sup>st</sup> Street)

Go to 1<sup>st</sup> & 8<sup>th</sup> Street.
